

## ***HANDLING OF PERSONAL INFORMATION BY USE OF OUR CONTACT FORM***

### **Data controller**

When using our contact form, you submit information to:

### **How do we use your personal information?**

KMC uses your information to contact you as follow up on your enquiry or request for contact and as natural follow up towards you on this. Apart from this, we do not use your information unless we agree otherwise in our dialogue.

### **Our basis for handling your personal information**

The basis for handling your personal information is the Data protection regulation paragraph 6, sub-paragraph 1 schedule f (interest balancing rule). The legitimate interest we are pursuing is to be able to get in contact with you based on your request for contact.

### **We do not pass on your personal information outside our group**

As a rule, we do not pass on the information received from you to third parties. However, for use in the answer to you pass on the information to one or more of our related companies to be able to answer your enquiry. Apart from this, we only pass on your information if authorities order us to do so or by any judicial act.

### **How long does KMC keep your data?**

When we have been in touch with you on your request and done a possible follow-up on this, we delete the information we have on you unless our contact to you cause further dialogue.

### **Your additional rights according to the Danish Data Protection Act**

You have a number of rights according to the Danish Data Protection Act. In case you wish to make use of your rights, please contact us.

Your rights also include the following:

- ***Eligible to insight***: You are eligible to gain insight in the personal information that we are handling on you.
- ***Eligible to retract***: You are eligible to retract incorrect personal information about you and to have incomplete personal information made complete.
- ***Eligible to delete (the right to be forgotten)***: In special cases, you are eligible to have your personal information deleted earlier than our usual procedure for deletion of your information.

- *Eligible to limitation of handling*: In certain cases, you are eligible to limit the handling of your personal information. If you are eligible to limit the handling, we are only entitled to handle your information - except for keeping it - with your approval in the future - or in preparation for a legal claim to be determined, maintained or defended, or to protect a person or important public interests.
- *Eligible to take exception*: In certain cases, you are eligible to take exception towards our handling of your personal information and always if our handling is in preparation for direct marketing.
- *Eligible to data portability*: In certain cases, you are eligible to receive your personal information in a structured, commonly used and machine readable format and to have this personal information transferred from one data controller to another.
- *Eligible to lodge a complaint*: At any time, you can lodge a complaint to the Danish Data Protection Agency on our handling of your personal information. Read more on [www.datatilsynet.dk](http://www.datatilsynet.dk), where you will also find further information about your rights as registered.
